- **Duly signed self-certification** of the university qualification obtained or the relevant certificate indicating the degree grade.
- **Copy of the receipt for the payment** of the fee to be paid upon registration (refundable exclusively in the event of failure to activate/not be admitted to the Master) to be paid by bank transfer to **LUMSA - Intesa Sanpaolo S.p.A.**
