- For non-European citizens: copy of residence permit or copy of the appointment at the Police Headquarters to request a residence permit; copy of passport and visa.
- Self-certification of the qualification obtained, duly signed, or the relevant certificate indicating the grade.
- Copy of the receipt of payment of the fee due upon registration (refundable only in the event of failure to activate/not being admitted to the master's degree) to be paid by bank transfer to LUMSA
